The Early Childhood Care and Education Authority (ECCEA), a parastatal body operating under the aegis of the Ministry of Education and Human Resource is inviting applications from suitably qualified candidates for the post of:

Accountant/Senior Accountant

(A) Qualifications

Candidates should:

- (i) possess a pass at the final examination required for admission to membership of one of the following bodies –
 - (a) The Institute of Chartered Accountants in England and Wales
 - (b) The Institute of Chartered Accountants of Scotland
 - (c) The Institute of Chartered Accountants of Ireland
 - (d) The Association of Chartered Certified Accountants
 - (e) The Chartered Institute of Management Accountants
 - (f) The Chartered Institute of Public Finance and Accountancy

OR

possess an equivalent qualification acceptable to the Board.

- (ii) be registered with the Mauritius Institute of Professional Accountants (MIPA) in accordance with Section 51 (2) of the Financial Reporting Act 2004;
- (iii) be computer literate;
- (iv) have personal credibility and integrity and excellent financial control skills; and
- (v) be able to lead and work in a team.

Note: Candidates should produce written evidence of experience claimed

(B) Duties:

1. To be responsible to the Director for all financial and accounting business, including procurement and supply of the Authority
2. To be responsible for the financial management of the Early Childhood Care and Education Authority
3. To advise the Director on all aspects of Financial Management.
4. To ascertain that statutory provisions and internal regulations relating to the financial management of the Authority are complied with.
5. To establish and maintain proper accounting and financial control systems and procedures.
6. To be responsible for maintaining proper record of the Authority's financial transactions and prepare financial statements.
7. To make arrangements for the safe and efficient collection and custody of sums owing and discharge of sum due.
8. To be responsible for the safe-keeping of all financial documents.
9. To prepare and submit the annual estimates, final accounts and annual and periodical reports on financial matters of the Authority
10. To carry out feasibility studies regarding projects of the Authority.
11. To supervise the work of and train staff of the Finance and Accounts Divisions.

12. To ensure that all audit programmes are well coordinated.
13. To make use of Information and Communication Technology in the performance of his duties.
14. To perform such other duties directly related to the main duties listed above or related to the delivery of the output and results expected from the Accountant in the roles ascribed to him.

The permanent and pensionable post of Accountant/Senior Accountant carries
